### Langley Dog Walker Service Owner Agreement

1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending "dog walking" with Langley Dog Walker.
2. I further understand and agree that in admitting my dog(s) to the Langley Dog Walker, the Langley Dog Walker and their staff have relied on my representation that my dog(s) is/are in good health and has/have not harmed or shown aggressive or threatening behaviour and are up to date on vaccinations.
3. I further understand and agree that Langley Dog Walker and their staff and will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog(s) attendance and participation with the Langley Dog Walker.
4. I further understand and agree that dogs can sometimes receive minor cuts and scratches at and any problems that develop with my dog(s) will be treated as deemed best by staff and volunteers of the Langley Dog Walker, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved.

I certify that I have read and understand the policies of the Langley Dog Walker as set forth in the preceding paragraphs and that I have read and understand the conditions and statements of this agreement, including the following:

**FEES:** Fees are due on the day of the walk. Regularly scheduled clients can be billed monthly for the walks or purchase a pre-pay package for Dog Daycare. Pre-pay packages are non-refundable except in extreme cases.

**RESERVATIONS:** Are required. Priority will be given to clients whose dog attends on a regular basis. Cancellations less than 12 hours notice may be charged full fees.

I agree to allow Langley Dog Walker personnel, and their employees to enter my home as pre-arranged for the purpose of picking up and returning of my pet. \_\_\_\_\_ (initials).
