



Langley Dog Walker Service Owner Agreement

I _____, hereby certify that my dog(s): _____

is in good health and has/have not been ill with any communicable condition in the last 14 days. I further certify that my dog(s) has/have not harmed or shown aggressive threatening behavior towards any person or any other dog. I have read and understand the following.

1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending "dog walking" with Langley Dog Walker.
2. I further understand and agree that in admitting my dog(s) to the Langley Dog Walker, the Langley Dog Walker and their staff have relied on my representation that my dog(s) is/are in good health and has/have not harmed or shown aggressive or threatening behaviour and are up to date on vaccinations.
3. I further understand and agree that Langley Dog Walker and their staff and will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog(s) attendance and participation with the Langley Dog Walker.
4. I further understand and agree that dogs can sometimes receive minor cuts and scratches and any problems that develop with my dog(s) will be treated as deemed best by staff and volunteers of the Langley Dog Walker, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved.

I certify that I have read and understand the policies of the Langley Dog Walker as set forth in the preceding paragraphs and that I have read and understand the conditions and statements of this agreement, including the following:

PAYMENT: Payment can be made by e-transfer, cash, cheque or credit card through the PetPocketBook website. Invoices will be emailed to you on the first of the month with the previous months balance. Payment is due 3 days after the invoice is issued. If you consistently do not pay on time we may implement a \$20 late fee. If payment is not received 2 weeks after the invoice is issued we may no longer provide services until the balance is paid in full.

CANCELLATION POLICY: Pre booked walks cancelled within 24 hours will pay 100% of the cost of the service unless there are extenuating circumstances or special arrangements made.

I agree to allow Langley Dog Walker personnel, and their employees to enter my home as pre-arranged for the purpose of picking up and returning of my pet. _____ (Initials). In consideration of, and as inducement to the acceptance of my application, I hereby agree to indemnify and hold harmless Langley Dog Walker and its employees/representatives of any and all claims from myself or any member of my family, of injury, expenses, or damages to my dog or any handler sponsored by me so long as Langley Dog Walker and its employees/representatives are acting reasonably in fulfilling their duties within the scope of the services for which they were hired. In addition, I agree that I will defend and indemnify Langley Dog Walker for any injury, expense, costs or damages to any dog handlers or dogs, whether sponsored by me or not, or to third parties arising out of my own actions or the actions of my dog. I have read the above-stated provisions, and agree to accept those responsibilities.
